Shop and save on medical procedures

SmartShopper[®] is a price comparison tool that lets you compare the costs of common medical procedures.

As a Blue Cross customer, you can shop and compare price ranges for procedures in nearly 300 categories. The tool lets you compare procedures based on price, location (ZIP Code) and facility.

It's important to know that not all facilities displayed in SmartShopper may be in your plan's network. You can call Customer Service at the number on the back of your member ID card to check which hospitals, clinics and healthcare providers are in your plan's network.

Compare and save on your out-of-pocket costs

You can save by using SmartShopper and comparing prices for your medical procedures. **If you have a high-deductible health plan, you can often save a great deal when you choose a facility in your network that costs less.**

Costs for medical care can vary widely from one facility to the next. For example, the cost of a routine colonoscopy screening could differ by as much as \$2,000, or an MRI by \$500 or more, depending on where you get it.

Your insurance covers a certain percentage or amount of these costs, depending upon your plan. **But the lower the cost of the procedure, the less you may pay up front and out of your own pocket to cover deductibles or coinsurance.**

It pays to shop!

You can be confident of the care you receive, no matter which facility you choose. All of the facilities in your network meet our quality standards. And all healthcare providers listed on the SmartShopper tool are appropriately licensed to provide the services offered at those locations.

How SmartShopper Works

Access SmartShopper at **bcbsla.vitalssmartshopper.com**.

Create an online account on your first visit to the site. You'll need your member ID card # to sign-up. This information will be used to verify your membership.

Each time you visit SmartShopper, you'll log back in. Once you're on the site, you can shop for medical procedures and compare costs from a secure portal.

As with any medical service, you should follow your doctor's clinical guidance when deciding what types of care you need.

Who can use SmartShopper?

The SmartShopper site is open to any Blue Cross and Blue Shield of Louisiana customer 18 or older. It's also available to Blue Cross network providers.*

*SmartShopper is not available to Federal Employee Program members.

Vitals is an independent company that provides a website called SmartShopper. This website enables Blue Cross and Blue Shield of Louisiana members to compare doctors, facilities and costs of healthcare services.
